

## COVID-19 PROTOCOL FOR REGISTRATION AND PARTICIPATION IN THE 16TH INTERNATIONAL PARA ATHLETICS MEETING OF L'HOSPITALET

The Covid-19 health crisis makes it necessary to adopt a strictly of measures aimed at complying with the protocols established by the health authorities.

The establishment and fulfillment of the aforementioned measures requires a series of commitments and forms of action on the part, fundamentally, of the organizers and participants. Reading and acceptance of this document is an essential condition to be part of this competition. The participant declares:

1. That he/she commits to comply with the guidelines and will follow the recommendations contained in this protocol, as well as the instructions that are given by the sports authorities or organization personnel present at the competition in relation to the measures to avoid contagion by Covid-19.
2. That you agree not to attend or take part in the competition in the event that you suffer from symptoms that could be compatible with the spread of Covid-19. This will also be extended to cases in which the symptoms were suffered by third parties with whom the participant has or has had a contact from which a contagion could be derived objectively.
3. That, if they become aware of being affected by the Covid-19 virus, they undertake not to attend or take part in the event or competition as long as the health authorities do not state that participation does not pose a risk, good for his person, good for the rest of the assistants with whom he could have contact.
4. That, to the extent of its scope, and in any case when there have been circumstances that advise it, it has undergone the prescribed tests to check if it is or has been infected by Covid-19.
5. That he is knowledgeable /, accepts and assumes that, in the current state, there is an objective risk of contagion of Covid-19 with the consequences that could derive from it for his person in terms of health problems.
6. That, in the event of being infected by Covid-19, the participant exonerates the organization of any responsibility in relation to the possible damages that may arise for him or her.
7. That, in case a positive is detected during the development of the competition, the organization will be informed immediately, which will follow the recommendations of the Ministry of Health and will follow the protocol of the Ministry of Health.
8. That the participant accepts that when measures or decisions are adopted by higher authorities such as the Ministry of Health or the Ministry of Health with the aim of preserving the health of people in the field of competition, no They may consider the essential obligations of the organizer unfulfilled.
9. That the participant agrees that if he or she shows conduct or behavior of non-observance or non-compliance with the orders or instructions of the organization's staff in relation to the security measures in relation to Covid-19, they may be excluded / year disqualified from the event by decision of whoever acts as a sports authority (judge-referee or technical delegate).

10. That the participant accepts that the sporting measures set out in the previous section are understood without prejudice to other responsibilities that he or she may assume before the competent authorities (including federal disciplinary bodies) as a result of conduct or behavior of non-observance or non-compliance with the orders and instructions that are applicable, either in the sports-federative field, or in other different fields.

#### **PROTOCOL OF ACTION BEFORE AND DURING THE CELEBRATION OF THE 16TH INTERNATIONAL PARA ATHLETICS MEETING OF L'HOSPITALET**

##### **ACCESS TO THE INSTALLATION:**

- The facility will not be accessible without having duly completed and signed the Declaration of Responsibility document.
- It will be done in a staggered manner, maintaining a safety distance of 1.5m.
- The temperature of all the people who access the installation will be taken.
- It will be mandatory to use the hydroalcoholic gel dispenser enabled in the access area to the facility to disinfect hands.
- The masks will be used during circulation in common spaces: changing rooms, corridors, lobbies, etc. Masks will also be used in the competition area, except during warm-up, competition and cool-down in the case of athletes and guides.
- The installation's circulation marks will be respected.
- The competition will be held behind closed doors or with limited access following the guidelines set by the competent authority.

##### **DURING THE CELEBRATION OF THE RALLY:**

- Whenever possible, a physical safety distance should be maintained.
- The use of clothing will be avoided as much as possible. There will be designated changing rooms for athletes and guides if they have to be used. In this case, the maximum indicated capacity must be respected or, failing that, a maximum of 8 people per dressing room (minimum of 3 m<sup>2</sup> of surface per person).
- Make use of the points enabled with dispensers of hydroalcoholic gel.
- The organization will be in charge of cleaning and disinfecting the common areas and the competition equipment for common use.
- Exclusive use will be made of the own competition equipment: bottles, sports equipment, etc.

**STATEMENT OF RESPONSIBILITY FOR ATHLETES, GUIDES AND / OR COMPANIONS  
AND STAFF OF THE ORGANIZATION**

- c) I have not been in direct contact with people who have had or have any symptoms compatible with COVID-19 in the last 14 days.

2. That, in case of having a fever or presenting any symptom compatible with COVID-19, I will refrain from accessing the sports facility and withdraw my participation in the competition.

3. That I agree to comply fully and responsibly with the prevention, hygiene and safety protocol established by the organization of the Meeting.

In witness whereof, I sign this statement, in order to access the facility and participate in the competition, and explicitly consent to the treatment of the data contained in this declaration by the organization and the health authorities.
